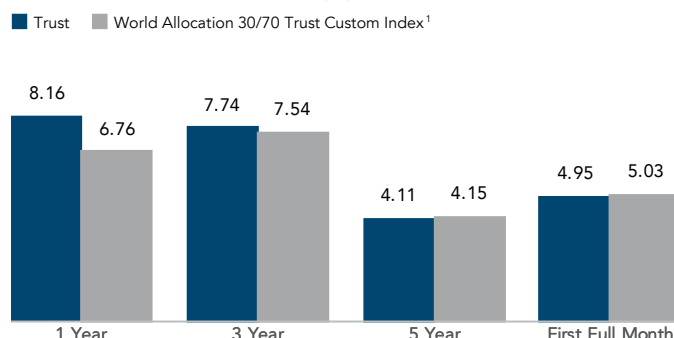
INVESTMENT OBJECTIVE

To provide a total return, consisting of capital appreciation and income, by gaining exposure to a diversified portfolio of domestic and global fixed interest securities, equity securities of companies and real estate securities listed on approved developed and emerging markets. The Trust will seek to target approximately 30% exposure to equities and 70% exposure to fixed interest assets. The Trust is not managed with the objective of achieving a particular return relative to a benchmark index.
