Investment objective

Vanguard Conservative Index Fund seeks to track the weighted average return of the various indices of the Underlying Funds in which it invests, in proportion to the Strategic Asset Allocation, before taking into account fees, expenses and tax.

Fund overview

The Fund provides low-cost access to a range of sector funds, offering broad diversification across multiple asset classes. The Fund is biased towards income assets, and is designed for investors with a lower tolerance for risk. The Fund targets a 70% allocation to income asset classes and a 30% allocation to growth asset classes.
